Rental fees must be paid in advance and are due by the first of each month.

To close a space, patrons must contact the Auto Skills Center (ASC) in person during normal working hours and complete the RV Storage Lot check out notification.

Late fee of \$10.00 (per space, per month) will be assessed on the 11<sup>th</sup> of the billing month.

All vehicles and trailers must be in working condition and have current registration, insurance, and license plates. Patrons must maintain adequate insurance on all vehicles placed in the MCCS RV Storage Lot. ASC staff will also obtain a copy of the patron's driver's license, vehicle insurance, and registration. Auto Skills patrons assume all risk of damage, loss, or destruction during storage and hold harmless the US Government or its agents from any such damage, loss, or destruction.

Overnight camping is **NOT** permitted in the RV Storage Lot, and **ONLY ONE (1)** vehicle or trailer is allow per assigned RV Storage spot.

Authorized patrons are responsible for maintaining the cleanliness of their assigned space. Any hazardous materials such as used tires, motor oil, anti-freeze, or paint are prohibited and cannot be stored in the facility. Gasoline cannot be stored with the exception of that within the vehicle/boat fuel tanks. Storage of excess accessories in and around the assigned space on the ground is prohibited. Maintenance or repair of vehicles in the lot is prohibited.

Accounts in arrears of 90 days will be denied access to the RV Storage Lot until the past due amount is paid in full.

Accounts in arrears of 180 days will be treated as abandoned property and processed for immediate removal. The local MCCS Finance Office will flag the account and forward the information to the Shared Services Center for collection.

Failure to abide by these regulations may be cause for immediate cancellation of the rental space, resulting in the removal of the vehicle. In the event of such a cancellation, rental charges will not be prorated.
